## MUNICIPAL BUILDING AUTHORITY OF TOOELE CITY, UTAH

#### **RESOLUTION 2023-02**

A RESOLUTION OF THE MUNICIPAL BUILDING AUTHORITY OF TOOELE CITY, UTAH APPROVING CONSTRUCTION CONTRACTS WITH BIG-D CONSTRUCTION CORP. FOR THE CONSTRUCTION OF THE NEW TOOELE CITY FIRE STATION #3.

WHEREAS, Tooele City operates and funds a volunteer fire department, the Tooele City Fire Department (TCFD); and,

WHEREAS, on August 18, 2021, the City Council approved Resolution 2021-83, approving an agreement with the Center for Public Safety Management LLC (CPSM) to perform a comprehensive analysis of fire services in Tooele City; and,

WHEREAS, on May 4, 2022, the City Council adopted CPSM's fire analysis report, one strong recommendation of which was to construct Fire Station #3 in order to augment TCFD's fire-fighting capacity, to protect fire apparatus by distributing them among the three fire stations, and to improve the City's ISO fire insurance rating, among other things; and,

WHEREAS, on November 4, 2009, the City Council approved Resolution 2009-55, authorizing the purchase of a three-acre site in anticipation of a future Fire Station #3; and.

WHEREAS, Tooele City has resolved to build Fire Station #3 in furtherance of CPSM's fire report's recommendations and in the public interest; and,

WHEREAS, the Municipal Building Authority of Tooele City, Utah (MBA) has obtained a loan in the amount of \$8.5 million from the State of Utah's Community Impact Board (CIB) for construction of Fire Station #3; and,

WHEREAS, Tooele City raised taxes beginning fiscal year 2023-24 to fund repayment of the CIB loan for Fire Station #3 (reference Resolutions 2023-67 and 2023-68, approved on August 18, 2023, approving a tax rate and a final FY23-24 budget); and,

WHEREAS, on December 21, 2022, the City Council approved Resolution 2022-105 regarding an agreement with PGS&W Architects for the design of Fire Station #3; and,

WHEREAS, on May 17, 2023, the MBA approved MBA Resolution 2023-01 regarding reimbursement of Fire Station #3-related expenditures incurred prior to CIB funding from CIB loan proceeds; and,

WHEREAS, following a competitive process in which Big-D Construction submitted to Tooele City the lowest and best bid, the MBA desires to enter into

construction and construction management contracts with Big-D for construction of Fire Station #3; and,

WHEREAS, the efficient and economical construction and construction management of the Fire Station #3 construction project and contracts is an important governmental purpose and in the best interest of Tooele City:

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL BUILDING AUTHORITY OF TOOELE CITY, UTAH that the Fire Station #3 construction and construction management contract documents attached hereto as Exhibit A, and all other documents necessary for Big-D to accomplish the construction of Fire Station #3, are hereby approved, and that the MBA Chair is hereby authorized to execute the same.

This Resolution is necessary for the immediate preservation of the peace, health	١,
safety, or welfare of Tooele City and shall become effective upon passage, without further	۶r
publication, by authority of the Tooele City Charter.
