Resolution 2020-

A Resolution of the Tooele City Council issuing a call for increased civility, respect for human life, freedom of expression, and property.

WHEREAS, the year 2020 will go down in history as the beginning and year of, the global pandemic known Coronavirus and,

WHEREAS, as of November 12, 2020, there have been 52,733,281 cases of COVID-19 (in accordance with the applied case definitions and testing strategies in the affected countries) that have been reported, including 1,293,181 deaths and,

WHEREAS, this disease does not discriminate who it attacks. It has effected all people, , regardless of all race, belief, nationality or financial status. No matter the gender, age, sex or circumstance it has infiltrated every community and killed our citizens indiscriminately and,

WHEREAS, the Coronavirus has disrupted every aspect of what we have considered as normal life in education. Schools have been closed temporarily more than once. Families, teachers and students have had to learn how to learn in a whole new way and,

WHEREAS, we experienced for the first time in a century the shutting down of a global and local economy. Many Tooele City citizens could not go to work for months and many businesses have lost countless amounts of money or been forced out of business and,

WHEREAS, the year 2020 has also been a time of great dissention and disregard for life, the rights of individuals and property owners. It has been a year marked with increases in our nation of murder, rioting, looting of businesses and destruction of property and

WHEREAS, there have been many peaceful protests decrying the unfair treatment of so many citizens of our county because of discrimination and,

WHEREAS, our great nation was founded upon The Bill of Rights and The Constitution of the United States, which grants each citizen the right to peaceably assembly, to exercise their freedom of religion, thought and expression. It grants to all citizens the right to own property, the freedom to vote for a candidate that each person desires to elect to be represent them and make and change laws that preserve the health, safety and freedom of its citizens and,

WHEREAS, the Declaration of Independence, the founding document of the United States of America, states, "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of happiness." Life being the first of these declared rights; and

WHERE AS, these very rights seem to be under attack, torn apart and forgotten based on differences of opinion, thought, and the free right to express one's self in the public square.

NOW, THEREFORE, BE IT RESOLVED BY THE TOOELE CITY COUNCIL that we declare that all life regardless of age or circumstance, must be protected by the laws of our society. We mourn for those that have lost loved ones during this year of pandemic. We support legislation on the state and national levels that protects human life. We invite all citizens to teach the importance of each individual life regardless of age, race, gender, sex, religious belief, philosophies or disability and to treat all people, especially those with whom we may differ in any area, with respect, civility and dignity. We call upon all citizens to live in a manner that will decrease violence in our society and to assist in changing our culture to reflect these values.

BE IT FURTHER RESOLVED that we call upon those running for office, those who have been elected to an office, heads of business, education, social movements, that may have cause to disagree each other to do so in manner that does not lead to violence, physical retaliation, the chilling of the rights of freedom of thought and expression or the taking of life or property. We invite all who enter into the public square to discuss the many differences we each may have for one another with civility and respect. We call upon those elected to represent us set forth the example of how to disagree with civility, work toward understanding our differences and collaborating on solutions that will move us forward to protect each person, their property and rights granted under the constitution. If this change cannot be effected by those who are elected to represent us then invite all to fulfill their duties as a citizens to get involved the electoral process by either becoming a candidate for office or by supporting a candidate who espouses their values and lastly to simply, vote.

BE IT FURTHER RESLOVED when the citizenry may not agree with a policy or law that is adopted or how the force of law is used. We invite any citizen to join in the public process and to express with civility disagreement to those elected to represent them of their values, feelings and thoughts regarding what their government is doing for and to them and,

BE IT FURTHER RESOLOVED that when there is disagreement with a law, policy or an injustice that is committed by a government or its officers, that citizens exercise the "right of the people peaceably to assemble, and to petition the Government for a redress of grievances." We call upon citizens who exercise this right to do so peacefully without the destruction of property, business or loss of life.

This Resolution is necessary for the health, safety and protection of the citizens of Tooele	and

CHAPTER 11. DESIGN REVIEW

7-11-16. Failure to act.

Should the applicant for any submitted application under this Chapter fail to resubmit corrected plans or application materials from any City review of the application within 180 calendar days from the return of that City review, the application shall be considered abandoned and all application fees forfeited. An abandoned application may be resubmitted as a new application at any time following abandonment, including the payment of new application fees.

CHAPTER 19. SUBDIVISIONS

7-19-14. Failure to act, effect.

- (1) <u>City.</u> Should the Planning Commission or the City Council fail to act upon any submitted preliminary plan application within the time period allotted by this Chapter, said failure shall be considered a denial of the said submission.
- (2) Application. Should the applicant for any submitted preliminary plan or final plat application fail to resubmit corrected plans or application materials from any City review of the application within 180 calendar days from the return of that City review, the application shall be considered abandoned and all application fees forfeited. For the purpose of this Chapter, abandoned applications shall be considered as if having never been submitted for review. An abandoned application may be resubmitted as a new application at any time following abandonment, including the payment of new application fees.

City Council Approval for Unclaimed Property Disposal as Public Interest Use 2020 -Tooele City Police Department

The bikes listed will be converted to public interest use and donated to the West Valley Fire Dept., a non-profit entity, to be repaired and sold with the proceeds being donated to the University of Utah Burn Unit. The firearms listed have been seized by the court and ownership transferred to the Tooele City Police Department. The firearms will be sold to a firearms dealer in Salt Lake City with the proceeds going to a credit account with that dealer for future purchase needs by Tooele City Police Department. The police department has taken the required steps as outlined in U.C.A. 77-24a-5 to attempt to locate owners of said listed property. These measures include; Publishing notice on the Utah Public Notice Website, notice listed on the Tooele City Police Website, notice listed on the Tooele City Police Facebook Page, notice published in the Tooele Transcript Bulletin public notices section, bulletins posted at the Tooele City Police Department lobby and Tooele City Hall public entry. Notices included links to or actual list of property with general descriptions and intended disposition date for disposal.






