NOTICE IS HEREBY GIVEN that a Special Meeting of the Governing Board (the "Board") of the Municipal Building Authority of Tooele City, Utah (the "Issuer"), will be held at the Board's Regular Meeting Place at 7:00 p.m. on May 17, 2023, for the purpose of authorizing a Reimbursement Resolution (the "Resolution") of the Issuer of its intent to issue bonds to finance and or reimburse the Issuer or Tooele City (the "City") for costs related to a new Fire Station (the "Project"). The Resolution contemplates that the Issuer intends on issuing bonds in an approximate amount of \$9,000,000 to be used in part or in whole to reimburse the Issuer or City for expenses incurred related to the Project, and for the transaction of such other business incidental to the foregoing as may come before said meeting. The meeting will be held in the Tooele City Hall Council Room Located at 90 North Main Street, Tooele, Utah.

RESOLUTION NO. 2023-01

A RESOLUTION OF THE BOARD OF THE MUNICIPAL BUILDING AUTHORITY OF TOOELE CITY, UTAH DECLARING ITS INTENTION TO REIMBURSE ITSELF FOR EXPENDITURES INCURRED IN CONNECTION WITH THE CONSTRUCTION OF A NEW FIRE STATION WITH PROCEEDS OF BONDS THAT IT INTENDS TO ISSUE, AND RELATED MATTERS.

WHEREAS, pursuant to the provisions of the Local Government Bonding Act, Title 11, Chapter 14, Utah Code Annotated 1953, as amended (the "Act"), The Municipal Building Authority of Tooele City, Utah (the "Issuer"), is authorized to issue bonds for the municipal purposes set forth in the Act; and

WHEREAS, the Issuer has determined that it would be in furtherance of the purpose of the Issuer and the Act to issue bonds (the "Bonds") to finance construction of a new Fire Station and all related improvements (the "Project"); and

WHEREAS, the Issuer plans to issue the Bonds and use a portion of the proceeds of the Bonds to reimburse itself or Tooele City, Utah (the "City") for expenditures incurred by the Issuer or the City relating to the Project and incurred prior to the date of issuance of the Bonds.

NOW THEREFORE, BE IT RESOLVED by the Governing Board of the Municipal Building Authority of Tooele City, Utah, as follows:

<u>Section 1.</u> All terms defined in the foregoing recitals hereto shall have the same meanings when used herein.

Section 2. The Board of the Issuer (the "Board") hereby finds and determines that it is in the best interests of the Issuer to issue bonds in the approximate amount of \$9,000,000 (the "Bonds") for the purpose of financing the Project. The Issuer hereby declares its intent to issue the Bonds and to use a portion of the proceeds thereof to reimburse itself or the City for expenditures incurred by the Issuer or the City relating to the Project and incurred prior to the date of issuance of the Bonds.

Section 3. If any provisions of this Resolution should be held invalid, the invalidity of such provision shall not affect the validity of any of the other provisions of this Resolution.

<u>Section 4.</u> All resolutions of the Board or parts thereof, inconsistent herewith, are hereby repealed to the extent only of such inconsistency.

Section 5. This Resolution shall become effective immediately upon its adoption.

Section 6. The Issuer hereby declares its intention and reasonable expectation to use proceeds of tax-exempt bonds to reimburse itself or the City for initial expenditures for costs incurred related to the Project. The Bonds are to be issued, and the reimbursements made, by the later of 24 months after the payment of the costs or after the Project is placed in service, but in any event, not later than 2 years after the date the original expenditure was paid. The maximum principal amount of the Bonds which will be issued to finance the reimbursed cost of the Project is not expected to exceed \$9,000,000.

Section 7. The Issuer hereby declares its intention that either the Issuer or the City intend to own the Series 2023 Project throughout its useful life and that ownership of the Project by the Issuer or the City furthers a legitimate public purpose.

<u>Section 8.</u> The Issuer hereby reserves the right to opt not to issue the Bonds for any reason.
