# II. Tooele Community Development Representative Presented By: Jim Bolser

As far as updates go, we've talked about Sunset Villas by Overlake Elementary by the round-about the planning commission approved their design last night. It's On the doorstep of starting development. There really hasn't been a whole lot of additional traffic as far as development around the Overlook area. By way of a longer-term update, the study work, and the design work for the traffic signal, 600 West 1000 North is moving slower than we anticipated. The design team didn't jump on things like we hoped they would. We're slower than we anticipated, but that is still moving. We've met with UDOT a couple of times here in the last couple of weeks. It's UDOTS contract company. We're participating because we have two legs in that intersection of 1000 North, that's why we've been coordinating with them. But this is the UDOT project. Part of the design includes a property survey.



Depending on the cross-sections of each leg, we may have some property acquisition. We don't know the extent of the leg work until they get deeper into the design. There is a cross section for that intersection at the specific points where they'll have to do the mounts for the semaphore. Unfortunately, it's a little bit slower but it is moving. We were hoping to see work by now, but maybe spring now. We're all hoping that the study work can be done over the winter during months that we wouldn't really want to construct that stuff. Then we get our legwork done and hopefully have actual construction in the spring. It all depends on how quickly the study gets done. Other than that, I don't know that we have anything real new and earth shattering. I can answer questions for you if you have any.

We cancelled our first meeting last month and held our second meeting on the second Wednesday. The only thing down in the north end of town was we approved two contracts for the Barrow, Wellhouse and Booster Station. They're building a million-gallon tank in the new subdivision down there along the railroad tracks.

Jim Bolser- If you go to the intersection of Berra and Aaron and look towards Wal-Mart, you can view it.

Justin Brady-These are just the booster stations to help pump the water. Other than that, we didn't have anything else that we discussed involving the north end of town, any questions?

Amanda Graf- Is it still secret who is coming into the development?

Justin Brady- The developer is going to be the one to announce that. My understanding is they're getting close to having the final plans.

Jim Bolser- We finished the review of their newest submittal yesterday; it was sent back to them today. We've identified a couple of minor tweaks that are remaining for formal approval plans. We've also given them the go ahead to start with their bonding work and that sort of thing to get started on site construction. I expect before we meet again, they will probably be going to be turning dirt.

Justin Brady- It's the developers project, they get to right when they announce it. They're getting letters of intent. But from what the mayor's told me that it's changed from their original plan. That's why they don't announce it, because then when it changes, No one knew it changed.
