## 3. <u>Recommendation on final plat approval for Vista Linda Phase 1 & 2. A 17 lot 5.64 acre</u> <u>subdivision to be located at approximately 240 South Droubay Road</u>

This application is a request for approval of a final plats one and two for approximately 5.64 acres located at approximately 240 S Droubay Road. The property is currently zoned R1-7 Residential. The applicant is requesting that a final plat be approved to allow for 17 single family residential lots with a minimum lot size of 7,000 ft<sup>2</sup>. The applicant has recorded an easement for a temporary turn around at the end of 1250 East for emergency vehicles. The preliminary plat was approved at their last meeting. The city Staff recommends approval of this project.

Chairwoman Bevan asked if there were any questions or comments from the Commission; there weren't any concerns.

Prior to voting, Commissioner Smart disclosed that he has done work for the builder, Jack Walters and Travis Sutherland. There is a slight chance he might do work for them again.

Commissioner Clark moved to forward a positive recommendation to the City Council for the Vista Linda Phase 1 & 2 final plats, for the purpose of creating 17 residential lots at approximately 240 South Droubay, application number P17-425, based on the findings and subject to the conditions listed in the Staff Report dated August 23, 2017. Commissioner Montano seconded the motion.
