Ms. Wimmer stated that there were a few minor changes to the RDA budget since the Board had last seen it. She pointed out \$300,000 was added for roadway improvements for Lodestone and G Avenue. Ms. Wimmer added that when she was given the budget, there were three line-items that were left blank. She took that to mean that the amount should be zero. Instead, it was meant that the amounts from last year were to be the same for this year's budget. Those amounts have been amended and carried forward for subscriptions and memberships, travel and training, and special department supplies.
