The meeting was called to order by Chair Hammer at 8:10 p.m.

### 1. Open Forum for Public Comment

No one was present from the pubic to make comments. Chair Hammer asked if anyone attended the county government proposal meeting held last night? Melodie Gochis said she had. He encouraged the board members to learn more about the committee's proposal for Tooele County.

### 4. Maintenance Coordinator's Report on Past and Present Actions

Mr. Maloy was not present to give his report. Ms. Manzione said there are several lights that have been installed that are not the correct fixture. Chair Hammer said that he talked to Paul Hansen about that. Ms. Manzione had sent Mr. Hansen a picture of the incorrect fixture but he did not receive it. Chair Hammer said that he would follow up and get another picture sent to Mr. Hansen. The repair lists have been sent and there are many burned out lights and they are not getting repaired as they should. Mike Maloy is supposed to get the information to Shilo Baker and Shilo Baker is supposed to coordinate the repairs.

Mr. Brondum explained to Melodie Gochis that this district has no assets. They are only in existence to maintain the amenities of the service district. The street light maintenance is not being done again.

Chair Hammer said he spoke to Paul Hansen about the three lights on 2000 North that are all out as well.

The board noted that the cobra head light by the hospital got knocked down and left there. Mr. Brondum was not sure that the city understands that they are responsible for the street lights on Main Street even though the road is controlled by UDOT. It was mentioned that the downed pole may have been picked up.
