A RESOLUTION OF THE REDEVELOPMENT AGENCY OF TOOELE CITY, UTAH, ADOPTING A BUDGET FOR FISCAL YEAR 2025-2026.

WHEREAS, the staff of the Redevelopment Agency of Tooele City, Utah ("RDA") has prepared and presented a proposed budget to the RDA's Board of Directors for the 2025-2026 fiscal year; and,

WHEREAS, the proposed budget was prepared in accordance with the requirements of U.C.A. §17C-1-601, et seq., as amended; and,

WHEREAS, the RDA held a required public hearing on the proposed FY 2025-2026 budget on June 18, 2025:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE REDEVELOPMENT AGENCY OF TOOELE CITY, UTAH, as follows:

1. That the fiscal year 2025-2026 RDA budget is hereby adopted; and,

2. The RDA Secretary is hereby directed to file a copy of said budget within 90 days of the date of this Resolution with (a) the Tooele County Auditor, (b) the State Tax Commission, (c) the State Auditor, (d) the State Board of Education, and (e) each other taxing entity from which the RDA receives project area funds (if any), as required by Utah Code Ann. §17C-1-601.5(6).

3. <u>Resolution 2025-01 A Resolution of the Redevelopment Agency of Tooele City, Utah,</u> <u>Tentatively Adopting a Tentative Budget for Fiscal Year 2025-2026, and Establishing the Time</u> <u>and Place of a Public Hearing to Consider its Adoption</u>

Presented by Shannon Wimmer, Finance Director

Ms. Wimmer presented the item, noting that this would be the first fiscal year in which the RDA would not receive tax increment revenue due to the official sunset of the district. However, she clarified that the City still had five years remaining to complete the RDA's existing projects and goals.

Ms. Wimmer stated that the tentative budget had been prepared in coordination with the RDA Chair and was included in the members' budget books under Fund 75. She welcomed questions at that time or in the future as members had more time to review the document. No questions were raised during the meeting.

Following brief discussion about scheduling, the board confirmed that the tentative budget would be voted on that evening, with final consideration and adoption scheduled for the second meeting in June, tentatively set for June 18, 2025.

Motion: Councilman Brady moved to approve Resolution 2025-01, a Resolution of the Redevelopment Agency of Tooele City, Utah, tentatively adopting a tentative budget for Fiscal Year 2025-2026, and establishing the time and place of a public hearing to consider its adoption. Councilman Hansen seconded the motion. The vote was as follows: Councilman Brady, "Aye"; Councilwoman Gochis, "Aye"; Councilman Hansen, "Aye"; Councilwoman Manzione, "Aye"; and Vice Chairman McCall, "Aye". There were none opposed. The motion passed.
