

## North Tooele City Special Service District Business Meeting

Chairman Hammer called the meeting to order at 8:04 p.m.

## **1. Discussion of the tentative budget for FY2025**

Mr. Brady presented the budget for FY2025. The district will have a small increase in property taxes to be in line with the certified tax rate. There will be no rate change, just a dollar amount change. Maintenance landscape was increased by \$10,000 due to the increasing costs and fence repairs.

#### 2. Open Forum for Public Hearing

The public forum was opened. No one came forward. The public forum was closed.

# 3. <u>Presentation and Questions by Lynsi Neve with Perry Homes about what the intend to annex into the NTCSSD.</u>

Ms. Neve presented the intention of Perry Homes annexing into North Tooele Special Service District. The landscape on 3100 North would have 18-20 feet of park strip with alternatives for trail options with varying treatments. Perry Homes would like to see the NTCSSD's design standards. This will help make specific designs for the development. This will need to be approved immediately to move the forward. Perry Homes would like to come back in August to receive approval. They would like to do this project annexed in all at once, possibly including the lots by the temple.

Council Member Brady addressed the board. The Mayor and City staff will work with Perry homes to set standards. The landscape, stoplights, and lights are specific to City standards.



The board discussed the park strips buffer to help with snow plowing and weather conditions/cleanup. As well as adding a drip system.

# 4. City Council Report

Presented by Councilman, Justin Brady

Council Member Brady presented the following items from the City Council meeting: A commercial property north of Home Depot has asked the City to pay for the water. They are planning to invest over \$100 million into this project. The Council approved a rezone for the property with the condition that the development would have to join the district. The 1000 North project is moving forward. The budget has been approved for FY2024-2025.

### 5. Maintenance Coordinator's Report on Past and Present Actions

Board Member Call presented a few areas that need repairs including a few street lights.

### 6. Jensen Family Landscape Report

Mr. Springer presented an updated for landscaping. The flowers have been planted. They have fixed a few sprinklers, painted most of the bridge where it was needed, and completed round two of fertilizing. There is a dead tree by the bridge that needs to be removed.

## 7. Vice Treasurer's Report

#### A. Approval of Invoices and Reimbursements

Mr. Winder presented the following invoices:
