## MAYOR'S MESSAGE

**MAYOR DEBBIE WINN**

If you received a letter from Tooele City about your water service line last November, we're asking for your help! As part of a federal requirement, we are working to identify the material of all water service lines in our community. There was a link to an online survey in your letter, completing the survey will help us meet this goal and ensure the safety of our water system.

**Why now?** The EPA recently updated rules requiring all drinking water systems to inventory and report the materials of water service lines. This is a proactive effort to ensure communities are safe from potential risks associated with lead pipes.

### How can you identify your service line material?

- 1. Visual Inspection:** Lead pipes are dull gray and soft to the touch. A scratch test will reveal a shiny silver surface.
- 2. Magnet Test:** Magnets stick to galvanized pipes but not to lead pipes.
- 3. Contact a Plumber:** A professional can help confirm your service line material.

Tooele City is here to assist! If you need help identifying your service line, call the Public Works Department at 435-843-2130. We can provide guidance over the phone or arrange for a crew to visit your property, typically within 24 hours of your call.

**Important to Know:** If you received a letter, that does not mean your water contains lead. It means we are working to identify the material of your service line. If you did not receive a letter, it means that your service line material is already recorded in our system and you do not need to complete the survey. If a home does have a lead service line, it's important to note that lead will not automatically enter the drinking water. Lead contamination typically occurs only when water has high acidity or low mineral content, which can cause pipes and fixtures to corrode. In most cases, drinking water from lead pipes remains safe as long as the water's pH and mineral content are balanced. The City's water is regularly and rigorously tested to ensure it meets safety standards, and any potential risks from lead are minimal unless there is prolonged contact with corrosive water. Rest assured, we remain committed to ensuring clean, safe drinking water for all residents. **City Council meetings are generally held the 1st and 3rd Wednesdays of every month at Tooele City Hall. Meetings are open to the public and are available through livestream on YouTube (Search “Tooele City Channel”). ## THE ROLES AND RESPONSIBILITIES OF THE MAYOR AND THE CITY COUNCIL

Tooele City operates under a Mayor/Council form of government as determined by our City Charter and City Code.

The Mayor is the Chief Executive Officer and the City Council is the Legislative Body. This system is modeled after the Federal Constitution structure of government. The Mayor and Council roles differ as they are separate yet equally important branches of the government, and together they work toward the well-being and betterment of our City. Here is a brief summary of the roles of each office:

### MAYOR

The Mayor is elected by residents separately from the Council and serves a four-year term with no term limit. The position is nonpartisan, full-time, and paid.

The Mayor is the Chief Executive Officer and Administrative authority of the City which includes:

- ⇒ As the Budget Officer of the City, the Mayor proposes a tentative annual budget to the City Council;
- ⇒ Oversees that all laws, ordinances, and resolutions are faithfully executed;
- ⇒ Appoints City Department Directors;
- ⇒ Manages the day-to-day operations of the City. The Mayor supervises all departmental activities through the Department Directors and has responsibility over:
  - ◆ The Finance Department, City Attorney’s Office, City Recorder’s Office, Human Resources Department, Police Department, Fire Department, Community Development Department, Public Works Department, Parks and Recreation Department, Information Technology Department, Economic Development Department, City Hall, and other administrative departments as may be created or amended from time to time;
    - Included as part thereof, the Mayor has direct supervision of the construction, improvements, repairs, and maintenance of streets, sidewalks, alleys, sewers, drains, ditches, culverts, streams and water courses, gutters and curbs; of all public buildings, boulevards, parks, playgrounds, squares, and other grounds and facilities belonging to the City; and the collection and disposal of waste materials.
    - To care for and preserve all machinery, tools, appliances, facilities, and property belonging to the City.
    - To oversee the issuing of building permits, the inspection of buildings, plumbing, and wiring, subject to uniform codes adopted by the City.
    - To act as the purchasing agent for the City through an authorized designee, to see that city codes and purchasing policies are adhered to, to approve all claims against the City less the \$30,000, and to see that all goods purchased by and for the City are received as per contract.

The Mayor also functions as the Executive Director of Tooele City’s Redevelopment Agency.

### CITY COUNCIL

The City Council consists of five nonpartisan members elected at large by Tooele City residents.

Council Members serve four-year terms with no term limit, work for the City part-time, and are paid.

The City Council exercises the legislative powers of city government, including:

- ⇒ Adopt the annual City budget and appropriate funds;
- ⇒ Propose and adopt ordinances (laws) and resolutions;
- ⇒ Approve Mayoral appointments of City Department Directors;
- ⇒ Set appropriate tax levies, establish sewer and water rates, set other general tax and service rates;
- ⇒ Approve all purchases and contracts that are greater than \$30,000; and,
- ⇒ Set the Council meeting agendas.

The Council also functions as the Board of Directors for Tooele City’s Redevelopment Agency, the Municipal Building Authority, and the Tooele City Water Special Service District.

**Use Extreme Caution!**

**Tooele City Fire Department would like to remind you of the Dangers of Thin Ice - Use Extreme Caution**

As winter settles in and lakes freeze over, it's important to remember that not all ice is safe. Thin ice can be deceptive, and stepping onto it can lead to tragic consequences. Please heed the following safety tips to stay safe this winter:

1. **Check Ice Thickness:** Always verify the thickness of the ice before venturing onto it. Ice should be at least 4 inches thick for walking, and thicker for other activities like skating or snowmobiles. If you're unsure, don't risk it!
2. **Avoid Frozen Bodies of Water During Warm Spells:** Ice conditions can change rapidly especially during temperature fluctuations. If temperatures rise, avoid going onto the ice entirely.
3. **Stay Aware of Hidden Hazards:** Areas near water inlets, currents, and under bridges often have thinner ice. Also, beware of areas with snow cover that may hide weak spots.
4. **Always Go with a Buddy:** Never go out on the ice alone. If an accident occurs, having someone nearby can make all the difference.
5. **Carry Safety Gear:** Consider wearing a life jacket, carrying a whistle, and bringing ice picks to help pull yourself out if you break through.
6. **Act Quickly if You Fall Through:** If you fall through the ice, try to stay calm. Attempt to pull yourself back up by spreading your arms wide to distribute your weight. Crawl to safety if possible.

Remember — Your safety is in your hands. Thin ice is unpredictable, and no adventure is worth risking your life. Stay safe and enjoy the winter season responsibly.

*At the time of this publication, the Settlement Canyon Reservoir, which is owned by the Settlement Canyon Irrigation Company, was closed to the public due to safety concerns.*

**Snow Event Parking Restrictions and Winter Weather Reminders**



**Snow Event Parking Restrictions**

Tooele City Code 10-3-6(1) states: "10-3-6. Snow Event Parking Restrictions"

- (1) It shall be unlawful to park a vehicle on any public right-of-way:
- (a) when snow is falling upon that vehicle; or,
  - (b) when snow or ice have accumulated in any amount on the right-of-way upon which that vehicle is parked.
- (2) Any vehicle parked in violation of this Section may be removed at the discretion of the Tooele City Police Department for creating public safety risks and for obstructing the City's snow removal efforts.
- (3) The following are exempt from this section:
- (a) Emergency vehicles and personnel in the performance of their functions and duties; and,
  - (b) Tooele City public works vehicles and employees in the performance of their functions and duties.

**Do not park your vehicles on the street when snow is falling or when snow or ice have accumulated.**

Snow parking restrictions are being enforced! You may be ticketed if you are in violation of this ordinance.

Our officers are not able to get to every part of the City during a storm to watch for parking violations— if you see a violation of this ordinance, please contact Tooele County Dispatch at 435-882-5600.

During the winter months, we want to remind you that residential and business sidewalks must be cleared of snow, hail, ice, and sleet within 24 hours after a storm stops. This is especially important in areas that are school walking routes! Tooele City Code 4-11-15(1) states: "It is unlawful for any person owning or exercising control over any real property abutting any public sidewalk to fail to remove or cause to be removed from such sidewalk all hail, snow, or sleet falling thereon, or ice forming thereon, within 24 hours after such hail, snow, or sleet has ceased falling or ice has ceased forming."

When the snow falls, don't let our students fall! Please keep all sidewalks that border your property clear, including the sidewalks along your back or side yards adjacent to the street (double frontage)! We need your help especially along school walking routes!

Please do not place or propel snow, hail, ice and sleet in a roadway or other portions of sidewalks. Tooele City Code 4-11-15(2) states: "It is unlawful for any person to place or propel, or cause to be placed or propelled, snow, ice, hail, or sleet in the public way or in any manner which poses a hazard to vehicular or pedestrian traffic."

Please be courteous to your neighbors; do not blow leaves, snow, or other debris into their yards. We encourage neighbors to help their neighbors shovel their driveways and sidewalks, especially for those who are unable to remove the snow themselves. Thank you!

**PLEASE KEEP PLASTIC BAGS OUT OF YOUR RECYCLING BIN!**  
**Plastic bags do not belong in the recycling bin.**

Plastic bags, wraps, and films cannot be recycled in your curbside recycling bins. When plastic goes through the sorting equipment at the recycle facility, it can bind up and damage the machines. You can take some of these items to local retail stores where they collect plastic grocery bags for recycling.

Did you know bagged recyclables will end up at the landfill?!?  
 Let's keep stretchy plastic out of our recycling bins!

**Animal Licenses**

It is now Animal License Renewal time for 2025. Please renew your animal license by Feb. 28, 2025. License fees double on March 1, 2025.

All dogs and cats within Tooele City limits and over the age of four months must be licensed each year. The license renewal application must be accompanied by a current rabies vaccination certificate. License renewal fees may be paid at Tooele City Hall (90 North Main Street, Tooele) in the Finance Department. If you have any questions, please contact the Finance Dept. at (435) 843-2150.

**STREET LIGHT AND STORM DRAIN FEE INCREASE**

**Attention Tooele City Customers:**

After a comprehensive external study of the street light and storm water systems, it has been determined that a fee increase is necessary in order to properly maintain and provide additional infrastructure for these systems. Effective January 1, 2025, Tooele City implemented the newly adopted fees for street light and storm water fees. Please see the graph. The new rates are reflected on the bill dated January 26, 2025.

**YOU CAN REPORT CRIMES ONLINE THROUGH OUR ONLINE REPORTING TOOL!**

The Tooele City Police Department offers an Online Reporting Tool for citizens of Tooele City to report crimes that have occurred within Tooele City limits. If the crime happened outside of Tooele City limits, please call Tooele County Dispatch at 435-882-5600, option #1 so the appropriate agency can respond. If your crime happened within Tooele City and you would rather file your police report online instead of meeting with an officer, go to the Tooele City Police website [tooelecity.gov/police](http://tooelecity.gov/police) and click on the "File a Police Report" link under the Related Links Menu. Read the instructions fully to make sure your case is eligible for online reporting.

Online reporting is not for: Reporting emergencies, crimes in progress, violent crimes, or if you need to speak with an officer quickly. For emergencies, please dial 911, if you need to speak with an officer and it is not an emergency, please call Dispatch at 435-882-5600, option #1. If you have questions about the online reporting system, you can contact the Police Dept. at 435-882-8900 Monday through Friday 8 am to 5 pm.

Here is a list of crimes that are eligible to be filed online: Credit Card Fraud, Identity Theft, Fraud/Scam, Lost Property, Found Property, Retail Theft, Telephone Harassment, Vehicle Burglary, Illegal Dumping, Graffiti, Vandalism, Property Damage, Hit and Run (no known suspect), Vehicle Accident (if damage is less than \$2500), Mail/Package Theft, Theft of Services, Theft.

Upon completion of the online reporting process, you will be given a police report case number and you will be able to print a copy of the police report to keep for your records.

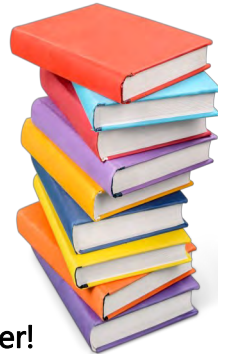

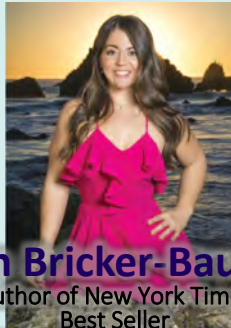

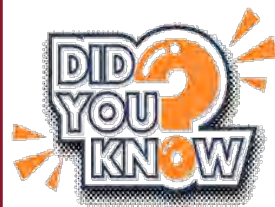
