ORDINANCE 2024-34

AN ORDINANCE OF THE TOOELE CITY COUNCIL RATIFYING THE APPROVAL OF ORDINANCE 2024-21 AND RE-APPROVING THE ANNEXATION PETITION OF HOWARD SCHMIDT, ANNEXING 61.16 ACRES OF LAND INTO THE TOOELE CITY CORPORATE LIMIT, AND ASSIGNING THE R1-8 RESIDENTIAL ZONING DISTRICT TO THE ANNEXED PROPERTY.

WHEREAS, on August 21, 2024, the City Council approved Ordinance 2024-21: "An Ordinance of the Tooele City Council Approving the Annexation Petition of Howard Schmidt, Annexing 61.16 Acres of Land into the Tooele City Corporate Limit, and Assigning the R1-8 Residential Zoning District to the Annexed Property"; and,

WHEREAS, the State of Utah has deemed the City's delivery of Ordinance 2024-21 and associated documents to be untimely and has required re-approval of the Canyon Springs annexation ordinance, which is accomplished by way of this ratification and re-approval ordinance (see State of Utah correspondence attached as Exhibit A; Ordinance 2024-21 and its exhibits are incorporated herein by this reference as Exhibit B); and,

WHEREAS, the annexation of additional land into Tooele City is governed by Utah Code Chapter 10-2 Part 4 (§10-2-401 *et seq.*), Tooele City Code Chapter 7-24, and Tooele City's Annexation Policy Plan (2024); and,

WHEREAS, Tooele City has received the annexation petition ("Petition") of Howard Schmidt ("Petitioner"), dated April 25, 2024, in accordance with UCA § 10-2-403 and TCC Chapter 7-24, seeking to annex approximately 61.16 acres of property (the "Property) into the Tooele City corporate limits; and,

WHEREAS, the parcel affected by the Ordinance is No. 03-031-0-0014; and,

WHEREAS, the City Council approved Resolution 2024-45 on June 5, 2024, which Resolution accepted the Petition for further consideration, as provided in UCA § 10-2-405(1); and,

WHEREAS, on July 10, 2024, the Tooele City Planning Commission considered the Petition and voted to forward its recommendation to the City Council, as required by TCC §7-24-1; and,

WHEREAS, by Ordinance 2023-45, the City Council adopted an updated Annexation Policy Plan, a document required by UCA §10-2-401.5, which plan includes the Property as eligible for annexation; and,

WHEREAS, at the recommendation of the City Administration, and at the request of the City Council, the Petitioner obtained professional engineering and other studies regarding the anticipated impacts of the Canyon Springs annexation on City utility,

infrastructure, and fiscal systems; and,

WHEREAS, on July 3, 2024, the City Recorder certified the Petition, as required by UCA §10-2-405(2); and,

WHEREAS, as required by UCA §10-2-407(3)(b)(ii)(A), the City Council convened a required public hearing on July 17, 2024, and accepted public comments, protests and objections, including from affected entities (reference UCA §§10-2-401, 406, and 407); and,

WHEREAS, pursuant to TCC §7-24-3, any annexation approval is conditioned upon the Petitioner executing an Annexation Agreement with the City; and,

WHEREAS, on August 21, 2024, the City Council approved Resolution 2024-60, approving an Annexation Agreement for the Canyon Springs annexation; and,

WHEREAS, the Canyon Springs Annexation and general annexation concepts have been discussed in public City Council meetings as indicated above; and,

WHEREAS, pursuant to Tooele City Code §7-24-1(1)(f), a successful annexation petition must be approved by at least a two-thirds (2/3) majority vote of the City Council; and.

WHEREAS, the City Administration believes that all the procedural requirements of both the Utah Code and Tooele City Code for the approval of an annexation have been satisfied:

WHEREAS, on July 17, 2024, the City Council convened a duly-noticed public hearing:

NOW, THEREFORE, BE IT ORDAINED BY THE TOOELE CITY COUNCIL that:

- 1. The Annexation Petition is hereby approved, subject to the conditions stated in this Ordinance and in the Annexation Agreement; and,
- 2. Petitioner shall immediately execute the approved Annexation Agreement; and,
- 3. As required in the Annexation Agreement, Petitioner shall execute an agreement with Tooele County for the paving of the trail referenced in the Agreement; and,
- 4. Subsequent to Petitioner executing both agreements referenced immediately above, but within 30 days of approval of this Ordinance, the City Recorder is hereby directed to file electronically with the Utah Lieutenant Governor a Notice of Impending Boundary Action meeting the requirements of the UCA §67-1a-6.5(3), together with a copy of the final local entity plat; and,
- 5. The property annexed under this Ordinance, as described in the Petition, shall receive the R1-8 Residential zoning district designation under authority of TCC §7-24-2 and the Annexation Agreement; and,

- 6. The annexation approved by this Ordinance shall take effect, according to UCA §10-2-425(4), on the date of the Lieutenant Governor's issuance of a Certificate of Annexation and recordation of the Certificate and the local entity plat with the Tooele County Recorder; and,
- 7. All aspects of this Ordinance, with the exception of the effective date of the annexation for State of Utah purposes under UCA §10-2-425(4), shall take effect immediately upon passage of this Ordinance, without further publication, by authority of the Tooele City Charter; and,
- 8. Ordinance 2024-21, and all actions taken and approval given, is hereby ratified and re-approved, and incorporated herein, together with its exhibits, by reference.

TOOELE CITY CORPORATION

RESOLUTION 2024-93

A RESOLUTION OF THE TOOELE CITY COUNCIL AMENDING THE TOOELE CITY FEE SCHEDULE REGARDING APPEALS OF LAND-USE RELATED CIVIL CITATIONS AND REVIEWS.

WHEREAS, Utah Code §10-3-718 authorizes the City Council to exercise administrative powers, such as establishing city fees and regulating the use of city property, by resolution; and,

WHEREAS, under the Council-Mayor form of municipal government, established and governed by the Tooele City Charter (2006) and Utah Code §10-3b-201 et seq., the Mayor exercises all executive and administrative powers; however, it has been the practice of Tooele City for all fees proposed by the Mayor and City Administration to be approved by the City Council; and,

WHEREAS, on August 21, 2024, the City Council approved Ordinance 2024-23 and amended Tooele City Code Chapters 7-1, 7-3, 7-5, 7-15, 7-15a, and 7-25 to include civil citations and penalties for chapter violations; and,

WHEREAS, it is necessary to establish civil citation appeal fees for inclusion in the Tooele City Fee Schedule; and,

WHEREAS, the City Administration recommends the following appeal fees, based on a consideration of the progressive civil citation penalties (i.e., increasing with each violation) and general impressions of the cost to hear appeals and conduct reviews:

- Chapter 7-1 (General Provisions): already set at \$25
- Chapter 7-3 (Legal Nonconforming Uses): recommend \$50
- Chapter 7-5 (Conditional Uses): recommend \$50
- Chapter 7-15 (Residential Facilities for the Disabled)—reasonable accommodation review: recommend \$150
- Chapter 7-15 (Residential Facilities for the Disabled)—civil citations: recommend \$100
- Chapter 7-15a (Residential Facilities for the Elderly)—reasonable accommodation review: recommend \$150
- Chapter 7-15a (Residential Facilities for the Elderly)—civil citations: recommend \$100
- Chapter 7-25 (Signs): recommend \$50

WHEREAS, all of the recommended fees are calculated to recoup a portion of the City's costs to administer the referenced reviews, and are anticipated to underrepresent those costs; and,

A RESOLUTION OF THE TOOELE CITY COUNCIL APPROVING AN AGREEMENT WITH S.F.T. CONCRETE FOR THE TOOELE LIBRARY STAMPED CONCRETE PROJECT.

WHEREAS, the City Administration has determined to replace turf sod park strips with colored, stamped concrete at the Tooele City Library (the Tooele Library Stamped Concrete Project, or Project); and,

WHEREAS, compliance with the notice and bidding procedures of UCA §11-39-101 *et seq.* and UCA §72-6-101 *et seq.* is not required for the Project because the Project cost does not reach the statutory cost threshold; and,

WHEREAS, the City has complied with the requirements of the Tooele City Purchasing Policies and Procedures; and,

WHEREAS, S.F.T. Concrete submitted the lowest responsive responsible bid, at \$59,800 (see bid results attached as Exhibit A); and,

WHEREAS, City Council approval is required for all agreements in excess of the statutory cost threshold of \$30,000 established in TCC §1-5-10 (see also TCC §1-6-4, §1-14-4, §1-22-4); and,

WHEREAS, the proposed Agreement is attached as Exhibit B; and,

NOW, THEREFORE, BE IT RESOLVED BY THE TOOELE CITY COUNCIL that the agreement with S.F.T. Concrete for the Project, in the amount of \$59,800, is hereby approved, and that the Mayor is authorized to sign the agreement on behalf of the City.

This Resolution shall become effective upon passage, without further publication, by authority of the Tooele City Charter.

AGREEMENT

TOOELE CITY CORPORATION, a municipal corporation of the State of Utah, (hereinafter "City"), and S.F.T. Concrete (hereinafter "Contractor") enter into this Agreement on the ____ day of________, 2024 (the "Effective Date").

Now, therefore, in consideration of the promises contained in this Agreement, the City and the Contractor agree to the following:

1. <u>Services (Scope of Work).</u> The Contractor shall provide the following services to the City:

The Tooele Library Stamped Concrete Project consists of the demolition and offsite disposal of approximately 5,300 square feet of existing sod, and the furnishing and installation therein of new colored, stamped concrete together with concrete curb tree wells, and concrete pads for picnic tables and related appurtenances.

- 2. <u>Disclaimer of Right of Control.</u> Contractor shall perform its duties competently. The City disclaims any right to control the Contractor's performance of the Services.
- 3. <u>Compensation.</u>
 - a. <u>Rate.</u> The City shall pay the Contractor the lump sum amount of \$59,800 for fully performing the Services, pursuant to invoice.
 - b. <u>Total Cost Contract.</u> This Agreement is a "Total Cost Contract." The contract Rate includes all costs and expenses associated with the provision of the Services.
 - c. <u>No Benefits.</u> The parties specifically agree that as an independent contractor, Contractor neither claims nor is entitled to benefits accorded City employees.
- 4. <u>Term of Agreement.</u> Contractor shall fully perform the Services by **May 30, 2025**.
- 5. <u>Termination.</u> The City may terminate this Agreement at any time. Should the City terminate this Agreement prior to the Services being fully performed, the City shall pay for those Services performed.
- 6. Indemnification and Insurance.
 - Contractor Liability Insurance. Contractor shall obtain and maintain liability insurance in the amount of at least \$1,000,000. Contractor shall list the City as an additional insured on endorsements issued under its liability insurance policy. Contractor shall require that all of its subcontractors list the City as an additional insured on endorsements issued under their respective liability insurance policies, with respect to the Services rendered under this Agreement.
 - b. <u>Contractor Indemnification</u>. Contractor shall indemnify and hold the City and its agents harmless from all claims of liability for injury or damage caused by any intentional or negligent act or omission of Contractor and/or its agents and subcontractors arising out of or related to this Agreement.
 - c. <u>Contractor Workers' Compensation Insurance</u>. Contractor shall purchase and maintain workers compensation insurance for all of its employees. In the alternative, assuming

eligibility, Contractor may obtain a Workers' Compensation Coverage Waiver from the Utah Labor Commission. Contractor shall verify that all its subcontractors have purchased and do maintain workers compensation insurance for their employees or have obtained an exclusion, and shall indemnify the City against claims resulting from a failure to obtain and maintain the insurance.

- d. <u>Performance and Payment Bonds</u>. Contractor shall obtain performance and payment bonds in form amount sufficient to the City.
- e. <u>Evidence of Contractor Insurance</u>. Contractor shall provide written evidence of liability insurance, including all Contractor and subcontractor endorsements, workers compensation insurance or exclusion, and payment and performance bonds to the City within ten (10) days of the Effective Date. The City will not make any payments under this Agreement until it receives from Contractor the evidence required under this section.
- f. <u>Status Verification Indemnification</u>. Contractor shall indemnify and hold the City and its agents harmless from all claims resulting from any violation of immigration status verification obligations contained in U.C.A. §63G-11-103 et seq.

- h. <u>Governmental Immunity</u>. The City is a governmental entity subject to the Utah Governmental Immunity Act ("Act"; U.C.A. Chapter 63G-7), and does not waive any procedural or substantive defense or benefit provided by the Act or by comparative legislative enactment, including UCA §63G-7-604 regarding limitation of judgments. Any indemnity and insurance obligations incurred by the City under this agreement are expressly limited to the amounts identified in the Act.
- 7. <u>Business License.</u> If required by Tooele City Code §5-1-1 *et seq.*, Contractor shall obtain a Tooele City business license.
- 8. <u>Complete Agreement.</u> This Agreement is the only agreement or understanding between the parties, and may be modified or amended only by a written document signed by both parties.
- 9. <u>Waiver of Jury Trial.</u> The Parties irrevocably waive any and all right to trial by jury in any legal proceeding arising out of or relating to this contract and the transactions contemplated.
