## **ORDINANCE 2025-27**

AN ORDINANCE OF THE TOOELE CITY COUNCIL AMENDING TOOELE CITY CODE SECTION 4-8-2 REGARDING ROAD CONSTRUCTION STANDARDS FOR LOCAL STREETS.

WHEREAS, Utah Constitution, Article XI, Section 5 directly confers upon Utah's charter cities, of which Tooele City is the only remaining such city, "the authority to exercise all powers relating to municipal affairs, and to adopt and enforce within its limits, local police, sanitary and similar regulations not in conflict with the general law"; and,

WHEREAS, in addition to the municipal powers bestowed by the Utah Constitution to Charter Cities, Utah Code Section 10-8-84 enables Tooele City to "pass all ordinances and rules, and make all regulations . . . as are necessary and proper to provide for the safety and preserve the health, and promote the prosperity, improve the morals, peace and good order, comfort, and convenience of the city and its inhabitants, and for the protection of property in the city"; and,

WHEREAS, the Utah Code grants authority to municipalities to regulate their public streets (see UCA 10-8-8, -8.6, -11, -23, -24, -25, -30, -32, and UCA Title 72 Chapter 3); and.

WHEREAS, TCC Chapter 4-8 regulates and establishes the standards for the construction of Tooele City's public streets, including dead end streets and cul-de-sacs; and,

WHEREAS, the City Administration recommends an amendment to TCC Section 4-8-2 regarding the width of local streets, including private streets, as outlined in attached Exhibit A; and,

WHEREAS, this amendment is necessary in order to harmonize Tooele City Code with current practices, as well as to continue Tooele City's compliance with House Bill 406 of the 2023 Utah Legislature established a state-wide maximum paved travel width of 32 feet for local streets, requiring the City to amend its local street asphalt width of 34 feet and right-of-way width of 60 feet to 32 feet and 58 feet, respectively (the 32 feet does not include the City' standard curb and gutter); and,

WHEREAS, while the City's road standards are not contained in TCC Title 7, the City Code's zoning and development title, and may not be considered a "land use regulation" as defined by state law, still, out of an abundance of caution, the City Council convened a duly-noticed public hearing on October 15, 2025:

NOW, THEREFORE, BE IT ORDAINED BY THE TOOELE CITY COUNCIL that Tooele City Code Section 4-8-2 regarding road construction standards is hereby amended as shown in Exhibit A, attached.

This Ordinance is necessary for the immediate preservation of the peace, health,
safety, or welfare of Tooele City and shall become effective immediately upon passage,
without further publication, by authority of the Tooele City Charter.

## TCC Section 4-8-2, As Proposed

## Proposed Amendments to Tooele City Code Modification of pavement width from 34' to 32' to be in compliance with current ROW sections

By Resolution 2023-21, the City Council made certain modifications to Tooele City Code (TCC) Title 4 - Chapter 8 Road & Bridge Construction Standards, that brought the City into compliance with House Bill 406 of the 2023 Utah Legislature that established a state-wide maximum paved travel width of 32 feet for local streets.

It is recommended that Section 4-8(2) Street Design be modified to more fully come into compliance with House Bill 406, as proposed below. This proposal allows a provision whereby the City can approved pavement width less than 30', breaks the requirements into sub-paragraphs for clarity, and eliminates language that may be redundant.

## TCC 4-8(2) Street Design

- (15) All streets proposed or intended to be built, owned, or maintained as private streets shall be designed and constructed to the same standards and specifications outlined in this Chapter for public local class or larger streets.
  - (a) Private streets may not be reduced in width narrower than 30 32 feet of asphalt with curb and gutter on each side unless approved otherwise thru a City Council approved Planned Unit Development (PUD), Residential Special District (RSD) or other formal Tooele City Council action. In no case shall the pavement width of a private street be less than allowed by the International Fire Code and Tooele City Code Chapter 3 Fire Code.
  - (b) Any private street proposed to be narrower than 34-32 feet of asphalt shall be required to prevent on-street parking through the provision of adequate off-street parking as outlined in Chapters 7-4 and 7-11a and through private enforcement. Land use applications that include proposed private streets that are narrower than 34 feet of asphalt shall include, and shall provide, as a part of the application, a mechanism by which perpetual private enforcement preventing on-street parking is assured. Applications that include private streets narrower than 34-32 feet in asphalt width shall be subject to review and approval of the proposed private street design and private parking enforcement mechanism by the designated approval authority for the type of land use application, following recommendation from the Tooele City Fire Chief, Community Development Department, Public Works Department, and the City Engineer. The City Attorney shall review the proposed private parking enforcement mechanism and provide a recommendation to the approval authority on that proposed mechanism.
  - (c) Land use applications may propose alterations to the cross section for the street regarding sidewalks and parkstrips but shall maintain pedestrian access of at least a 5-foot width throughout the development and in compliance with requirements of the Americans with Disabilities Act (ADA).

## **ORDINANCE 2025-28**

AN ORDINANCE OF TOOELE CITY AMENDING THE ZONING MAP PERTAINING TO THE TOOELE BUSINESS PARK ZONING DISTRICT BY RE-ASSIGNING THE LAND USE SECTIONS OF THE TBP ZONING SECTIONS MAP, AFFECTING APPROXIMATELY 285.1 ACRES OF PROPERTY LOCATED AT APPROXIMATELY 1100 WEST 700 SOUTH.

WHEREAS, Utah Code §10-9a-401, et seq., requires and provides for the adoption of a "comprehensive, long-range plan" (hereinafter the "General Plan") by each Utah city and town, which General Plan contemplates and provides direction for (a) "present and future needs of the community" and (b) "growth and development of all or any part of the land within the municipality"; and,

WHEREAS, the Tooele City General Plan includes various elements, including water, sewer, transportation, and land use. The Tooele City Council adopted the Land Use Element of the Tooele City General Plan, after duly-noticed public hearings, by Ordinance 2020-47, on December 16, 2020, by a vote of 5-0; and,

WHEREAS, the Land Use Element (hereinafter the "Land Use Plan") of the General Plan establishes Tooele City's general land use policies, which have been adopted by Ordinance 2020-47 as a Tooele City ordinance, and which set forth appropriate Use Designations for land in Tooele City (e.g., residential, commercial, industrial, open space); and,

WHEREAS, the Land Use Plan reflects the findings of Tooele City's elected officials regarding the appropriate range, placement, and configuration of land uses within the City, which findings are based in part upon the recommendations of land use and planning professionals, Planning Commission recommendations, public comment, and other relevant considerations; and,

WHEREAS, Utah Code §10-9a-501, *et seq.*, provides for the enactment of "land use [i.e., zoning] ordinances and a zoning map" that constitute a portion of the City's regulations (hereinafter "Zoning") for land use and development, establishing order and standards under which land may be developed in Tooele City; and,

WHEREAS, a fundamental purpose of the Land Use Plan is to guide and inform the recommendations of the Planning Commission and the decisions of the City Council about the Zoning designations assigned to land within the City (e.g., R1-10 residential, neighborhood commercial (NC), light industrial (LI)); and,

WHEREAS, on June 7, 2023, City Council approved Ordinance 2023-28, creating the Tooele City Business Park Zoning District; and,

WHEREAS, the City Administration requests consideration of an amendment to the Zoning Map as to the Tooele Business Park in order to align with current infrastructure needs and planning standards, with key changes including modifying potential lots to reflect existing and future water and sewer utilities, updating existing and proposed road layouts, revising lots and boundaries to reflect existing ownership, and eliminating the previously planned rail spur (see Staff Report attached as Exhibit A); and,

WHEREAS, the proposed amendment affects approximately 285.1 acres located at approximately 1100 West and 700 South as indicated in Exhibit B (see also Engineering Review attached as Exhibit C); and,

WHEREAS, on September 24, 2025, the Planning Commission convened a duly noticed public hearing, accepted written and verbal comment, and voted to forward its positive recommendation to the City Council:

NOW, THEREFORE, BE IT ORDAINED BY THE TOOELE CITY COUNCIL that:

- 1. this Ordinance and the Zoning Map amendment proposed therein is in the best interest of the City, in that it will provide consistent zoning for current infrastructure needs and planning standards; and,
- 2. the Zoning Map is hereby amended for the property located at approximately 1100 West and 700 South as requested and illustrated in Exhibit B.

This Ordinance is necessary for the immediate preservation of the peace, health, safety, or welfare of Tooele City and shall become effective immediately upon passage, without further publication, by authority of the Tooele City Charter.

#### BACKGROUND

The Tooele Business Park zoning map has been revised to align with current infrastructure needs and planning standards. Key changes include modifying potential lots to reflect existing and future water and sewer utilities, updating existing and proposed road layouts, revising lots and boundaries to reflect existing ownership, and eliminating the previously planned rail spur, which is no longer considered viable for the park's success based on analysis of costs.

## **ANALYSIS**

Summary of Proposed Changes to Tooele Business Park

The proposed updates to the Tooele Business Park focus on improving and aligning the development with current infrastructure needs and planning standards. Key changes include:

- 1. Infrastructure Improvements:
  - a. Water and Sewer: Modifications are being made to better accommodate existing and planned water and sewer utilities, ensuring capacity and alignment with city infrastructure.
  - b. Roads and Access: Roadway layouts are being updated to improve traffic flow and access throughout the business park. These changes reflect current and future transportation needs, including proper connections to public road systems.
- 2. Property Boundary Adjustments:

- a. Parcel boundaries are being revised to more accurately reflect existing ownership and development intentions, helping reduce conflicts and streamline future development or sale of parcels.
- 3. Rail Spur Elimination:
  - a. The previously planned rail spur is being removed from the development plans. This change reflects current economic and logistical needs, as the rail component is no longer seen as viable or necessary for the park's success.

<u>Criteria For Approval</u>. The criteria for review and potential approval of a Zoning Map Amendment Request request is found in Section 7-1A-7 of the Tooele City Code. This section depicts the standard of review for such requests as:

- (1) No amendment to the Zoning Ordinance or Zoning Districts Map may be recommended by the Planning Commission or approved by the City Council unless such amendment or conditions thereto are consistent with the General Plan. In considering a Zoning Ordinance or Zoning Districts Map amendment, the applicant shall identify, and the City Staff, Planning Commission, and City Council may consider, the following factors, among others:
  - (a) The effect of the proposed amendment on the character of the surrounding area.
  - (b) Consistency with the goals and policies of the General Plan and the General Plan Land Use Map.
  - (c) Consistency and compatibility with the General Plan Land Use Map for adjoining and nearby properties.
  - (d) The suitability of the properties for the uses proposed viz. a. viz. the suitability of the properties for the uses identified by the General Plan.
  - (e) Whether a change in the uses allowed for the affected properties will unduly affect the uses or proposed uses for adjoining and nearby properties.
  - (f) The overall community benefit of the proposed amendment

<u>Noticing</u>. The applicant has expressed their desire to rezone the subject property and do so in a manner which is compliant with the City Code. As such, notice has been properly issued in the manner outlined in the City and State Codes.

## **STAFF RECOMMENDATION**

Staff recommends the Planning Commission carefully weigh this request for a Land Use Map Amendment according to the appropriate tenets of the Utah State Code and the Tooele City Code, particularly Section 7-1A-7(1) and render a decision in the best interest of the community with any conditions deemed appropriate and based on specific findings to address the necessary criteria for making such decisions.

Potential topics for findings that the Commission should consider in rendering a decision:

- 1. The effect of the proposed application on the character of the surrounding area.
- 2. The degree to which the proposed application is consistent with the intent, goals, and objectives of any applicable master plan.
- 3. The degree to which the proposed application is consistent with the intent, goals, and objectives of the Tooele City General Plan.

- 4. The degree to which the proposed application is consistent with the requirements and provisions of the Tooele City Code.
- 5. The suitability of the properties for the uses proposed.
- 6. The degree to which the proposed application will or will not be deleterious to the health, safety, and general welfare of the general public or the residents of adjacent properties.
- 7. The degree to which the proposed application conforms to the general aesthetic and physical development of the area.
- 8. Whether a change in the uses allowed for the affected properties will unduly affect the uses or proposed uses for adjoining and nearby properties.
- 9. The overall community benefit of the proposed amendment.
- 10. Whether or not public services in the area are adequate to support the subject development.
- 11. Other findings the Commission deems appropriate to base their decision upon for the proposed application.







Dear John:

The following report provides a preliminary engineering assessment of the proposed Tooele Business Park located in Tooele, Utah. This report addresses high-level site access, site grading and earthwork, stormwater drainage features and potential retention/detention, water requirements, and sanitary sewer loading.

#### SITE ACCESS

The existing site lies in southwest Tooele and is bounded by the Tooele Army Depot to the south, Union Pacific Railroad mainline track to the west, current industrial businesses to the north, and residential subdivisions to the east. Site access is from the future highway (currently, 1100 West) from both the north and south. The southern end of the highway will connect to Highway 36 within the federal parcel. The site can also be alternatively accessed from the north on 1200 West and from three (3) roads (W 700 S, Timpie Road, and W 1220 S) coming from the east through the residential neighborhoods. The 3 access points from the east all connect to the retail/office parcels along the east edge of the development.

## **GRADING AND EARTHWORK**

The existing site slopes to the west-northwest at an approximate slope of 3.6 percent. Currently, there are native grasses and shrubs with miscellaneous unimproved roads and small drainage(s) throughout the site. Preliminary earthwork and grading numbers are based on the existing site topography and the concept layout located in Appendix A.

Grading/earthwork methodology includes topsoil stripping, site roads, and building pad development. Topsoil stripping includes removal of the top 6 inches across the site. Road volumes include removal of native material down to subgrade. Lot grading and building pad cut to fill volumes are based on the resulting surface post topsoil stripping being shaped to drain as well as creation of a flat, constructable building pad for the building square footage identified in the planning stage for each parcel. Estimated cut to fill volumes across the whole site are shown in Table 1 below.

Table 1 – Preliminary Site Grading/Earthwork Cut to Fill Volumes

Stormwater ponds will also be necessary and are not included in Table 1 above. Based on existing topography and the Concept Plan, the site was evaluated using a regional storage pond and local storage ponds for those parcels that do not gravity drain to the regional storage pond. Parcels requiring local storage ponds are Parcels 1, 2, and 3. A breakdown of the approximate cut volumes is shown in Table 2 below.

## **STORMWATER**

Storm calculations for the Concept Plan were completed based on the Rational Method. Based on the size of the development, this method is conservative and further analysis using other methods may reduce the size of required storage basins as the design for the site progresses.

Stormwater detention/retention was evaluated in three different ways. The first method was to detain the 10-year storm and release water at a rate of 0.2 cfs per acre. The second method

was the Low Impact Development (LID) method, where the 80<sup>th</sup> percentile storm is retained onsite and is additional storage volume above the 10-year storm. The third evaluation was to retain 100% onsite the 100-year, 24-hr storm which would be used if there was no viable connection to downstream storm infrastructure. The resulting volumes of each method are presented in Table 3 below.

Proposed stormwater retention/detention basins as well as site drainage channels can be viewed on the Concept Stormwater Drainage Plan within Appendix A.

## WATER

Water requirements for the proposed development were calculated based on the Tooele City Drinking Water Master Plan dated May 2021. Specifically, Equivalent Residential Connections (ERC) for both light industrial and neighborhood commercial in conjuction with Table 1-2: Peak Day Indoor and Outdoor Demand Level of Service were used to calculate total site water demand. ERC values and Table 1-2 and the Concept Site Water and Sewer Plan are located in Appendix B.

Based on the requirements of the Tooele City Drinking Water Master Plan, the total development will require approximately 1,461,555 gallons per day during peak day which equates to approximately 1,014 gpm.

Tooele provides 4,000 gpm for 4 hours from tank 3, and therefore, no additional volume of fire water storage should be needed.

The site will require an equilization storage of 600,700 gallons.

Based on the Tooele City Drinking Water Master Plan there is a planned 16-inch transmission line in S 900 W (See Figure 7-1 in Appendix B). Also, a well is located onsite

within Parcel #4 of the Concept Plan. Any future sanitary sewer line must be located a minimum of 25 feet away from the well.

#### **SANITARY SEWER**

The sanitary sewer requirements for the Concept Plan were evaluated. The following assumptions were made for this evaluation:

- Industrial 2 employees per 1,000 sf each shift for 3 shifts, no showers
- Office 6 employees per 1,000 sf
- 15 gpd sewer/person

Based on the above assumptions and the building square footages as indicated on the concept plan, the average sewer load is 445,941 gpd with the peak sewer being 1,114,852 gpd.

The Concept Site Water and Sewer Plan can be viewed in Appendix B.





Now, therefore, in consideration of the promises contained in this Agreement, the City and the Contractor agree to the following:

1. <u>Services (Scope of Work).</u> The Contractor shall provide the following services to the City:

The 2025 Tooele Library Stamped Concrete Project consists of the demolition and offsite disposal of approximately 3,025 square feet of existing sod, and the furnishing and installation therein of approximately 2,700 square feet of new colored, stamped concrete and related appurtenances.

- Disclaimer of Right of Control. Contractor shall perform its duties competently. The City disclaims any right to control the Contractor's performance of the Services.
- Compensation.
  - a. Rate. The City shall pay the Contractor the lump sum amount of \$35,250 for fully performing the Services, pursuant to invoice.
  - b. <u>Total Cost Contract.</u> This Agreement is a "Total Cost Contract." The contract Rate includes all costs and expenses associated with the provision of the Services.
  - c. <u>No Benefits.</u> The parties specifically agree that as an independent contractor, Contractor neither claims nor is entitled to benefits accorded City employees.
- Term of Agreement. Contractor shall fully perform the Services by March 31, 2026.
- Termination. The City may terminate this Agreement at any time. Should the City terminate this
  Agreement prior to the Services being fully performed, the City shall pay for those Services
  performed.
- 6. Indemnification and Insurance.
  - a. Contractor Liability Insurance. Contractor shall obtain and maintain liability insurance in the amount of at least \$1,000,000. Contractor shall name the City, its agents, officers, employees, and independent contractors as additional insureds for all liability arising from this Agreement. Contractor shall require that all of its subcontractors name the City, its agents, officers, employees, and independent contractors as additional insureds on endorsements issued under their respective liability insurance policies, for all liability arising from this Agreement.
  - b. <u>Contractor Indemnification</u>. Contractor shall indemnify, defend, and hold harmless the City, and its agents, officers, employees, and independent contractors, from and against all lawsuits, claims, damages, losses, or expenses (including attorney's fees) arising out of or related to this Agreement.

- c. <u>Contractor Workers' Compensation Insurance</u>. Contractor shall purchase and maintain workers compensation insurance for all of its employees. In the alternative, assuming eligibility, Contractor may obtain a Workers' Compensation Coverage Waiver from the Utah Labor Commission. Contractor shall verify that all its subcontractors have purchased and do maintain workers compensation insurance for their employees or have obtained an exclusion, and shall indemnify the City against claims resulting from a failure to obtain and maintain the insurance.
- d. <u>Performance and Payment Bonds</u>. Contractor shall obtain performance and payment bonds in form amount sufficient to the City.
- e. <u>Evidence of Contractor Insurance</u>. Contractor shall provide written evidence of liability insurance, including all Contractor and subcontractor endorsements, workers compensation insurance or exclusion, and payment and performance bonds to the City within ten (10) days of the Effective Date. The City will not make any payments under this Agreement until it receives from Contractor the evidence required under this section.
- f. <u>Status Verification Indemnification</u>. Contractor shall indemnify and hold the City and its agents harmless from all claims resulting from any violation of immigration status verification obligations contained in U.C.A. §63G-11-103 et seq.
- g. <u>Post-Retirement Release</u>. Contractor shall release the City from all claims related to any alleged violation of State of Utah post-retirement employment rules, and shall complete and return to the City the attached certification and release.
- h. Governmental Immunity. The City is a governmental entity subject to the Utah Governmental Immunity Act ("Act"; U.C.A. Chapter 63G-7), and does not waive any procedural or substantive defense or benefit provided by the Act or by comparative legislative enactment, including UCA §63G-7-604 regarding limitation of judgments. Any indemnity and insurance obligations incurred by the City under this agreement are expressly limited to the amounts identified in the Act.
- Business License. If required by Tooele City Code §5-1-1 et seq., Contractor shall obtain a Tooele City business license.
- 8. <u>Complete Agreement.</u> This Agreement is the only agreement or understanding between the parties, and may be modified or amended only by a written document signed by both parties.
- Waiver of Jury Trial. The Parties irrevocably waive any and all right to trial by jury in any legal proceeding arising out of or relating to this contract and the transactions contemplated.

A RESOLUTION OF THE TOOELE CITY COUNCIL APPROVING AN AGREEMENT CHANGE ORDER NO. 5 WITH BROKEN ARROW CONSTRUCTION FOR ENGLAND ACRES PARK PHASE III.

WHEREAS, on October 16, 2024, the City Council approved Resolution 2024-84, approving an agreement with Broken Arrow for the construction and installation of parking lot and landscaping improvements in Phase III of England Acres Park (the "Phase III Project"); and,

WHEREAS, the City solicited public bids for construction of the Phase III Project in accordance with the procedures of §11-39-101 *et seq.*, Utah Code Annotated, and the Tooele City Purchasing Policies and Procedures; and,

WHEREAS, in connection with the Phase III Project, the City Administration has determined that installing additional sod, topsoil, sprinklers, concrete, and other items are necessary and in the interest of Tooele City, and recommends the approval of Change Order No. 5 for the Phase III Project with Broken Arrow, in the amount of \$167,160.19 (see Change Order No. 5 attached as Exhibit A); and,

WHEREAS, compliance with the notice and bidding procedures of UCA §11-39-101 et seq., is not required for the Change Order No. 5 because the project cost does not reach the statutory cost threshold of about \$240,000; and,

WHEREAS, Section VIII of the Tooele City Purchasing Policies and Procedures provides for the approval of change orders, as follows:

- VIII. CHANGE ORDERS. The City recognizes that change orders are a normal component of the procurement process...
- A. Modifications to approved contracts shall be deemed change orders when the Mayor and Purchasing Agent determine that: 1. The modification is related in some manner to the same or similar project approved in the contract, and 2. Treating the modification as a change order would maximize efficiency in completion of and cost savings to the City.
- B. Change Order approval process: ... 2. Individual change orders \$30,000 and above shall be approved by the Mayor and City Council after consultation with the responsible department head...provided the change order is within the approved project budget.

WHEREAS, the Purchasing Policies and Procedures allow for Change Order No. 5 because the Mayor and Parks and Recreation Director have determined that the change

order is related to the agreement for the Phase III Project, and the change order will maximize efficiency in Project completion and result in cost savings; and,

WHEREAS, City Council approval is required for all agreements and change orders in excess of the statutory cost threshold of \$30,000 established in TCC §1-5-10 (see also TCC §1-6-4, §1-14-4, §1-22-4); and,

WHEREAS, on May 7, 2025, the City Council approved Resolution 2025-32, approving a Change Order No. 1 to the Phase III Project agreement; and,

WHEREAS, on May 7, 2025, the City Council approved Resolution 2025-40, approving a Change Order No. 2 to the Phase III Project agreement, for the Oquirrh Hills Project;

WHEREAS, on May 21, 2025, the City Council approved Resolution 2025-46, approving a Change Order No. 3 to the Phase III Project agreement, for the Oquirrh Hills Project;

WHEREAS, Change Order No. 4 to the Phase III Project agreement was for an amount less than the statutory cost threshold of \$30,000 established in TCC §1-5-10 (see also TCC §1-6-4, §1-14-4, §1-22-4), and thus had no accompanying resolution;

WHEREAS, the City has complied with the requirements of the Tooele City Purchasing Policies and Procedures:





TOOELE CITY CORPORATION, a municipal corporation of the State of Utah, (hereinafter "City"), and Speakman's Concrete Services of 222 East 500 North Tooele, Utah 84074, a(n) Limited Liability Company, (hereinafter "Contractor") enter into this Agreement on the 16<sup>th</sup> day of October, 2025 (the "Effective Date").

Now, therefore, in consideration of the promises contained in this Agreement, the City and the Contractor agree to the following:

- Services (Scope of Work). The Contractor shall provide the following services to the City:

- 2. <u>Disclaimer of Right of Control.</u> Contractor shall perform its duties competently. The City disclaims any right to control the Contractor's performance of the Services.
- 3. <u>Compensation.</u>
  - a. Rate. The City shall pay the Contractor the sum of \$49,395.00 for fully performing the Services, pursuant to invoice.
  - b. <u>Total Cost Contract.</u> This Agreement is a "Total Cost Contract." The contract Rate includes all costs and expenses associated with the provision of the Services.
  - c. <u>No Benefits.</u> The parties specifically agree that as an independent contractor, Contractor neither claims nor is entitled to benefits accorded City employees.
- 4. Term of Agreement. Contractor shall fully perform the Services by November 30<sup>th</sup> 2025.
- 5. <u>Termination.</u> The City may terminate this Agreement at any time. Should the City terminate this Agreement prior to the Services being fully performed, the City shall pay for those Services performed.
- 6. Indemnification and Insurance.
  - a. <u>Contractor Liability Insurance</u>. Contractor shall obtain and maintain liability insurance in the amount of at least \$1,000,000. Contractor shall list the City as an additional insured on endorsements issued under its liability insurance policy. Contractor shall require that all of its subcontractors list the City as an additional insured on endorsements issued under their respective liability insurance policies, with respect to the Services rendered under this Agreement.
  - b. <u>Contractor Indemnification</u>. Contractor shall indemnify and hold the City and its agents harmless from all claims of liability for injury or damage caused by any intentional or negligent act or omission of Contractor and/or its agents and subcontractors arising out of or related to this Agreement.
  - c. <u>Contractor Workers' Compensation Insurance</u>. Contractor shall purchase and maintain workers compensation insurance for all of its employees. In the alternative, assuming eligibility, Contractor may obtain a Workers' Compensation Coverage Waiver from the Utah Labor Commission. Contractor shall verify that all its subcontractors have purchased

- and do maintain workers compensation insurance for their employees or have obtained an exclusion, and shall indemnify the City against claims resulting from a failure to obtain and maintain the insurance.
- d. <u>Performance and Payment Bonds</u>. Contractor shall obtain performance and payment bonds in form amount sufficient to the City.
- e. <u>Evidence of Contractor Insurance</u>. Contractor shall provide written evidence of liability insurance, including all Contractor and subcontractor endorsements, workers compensation insurance or exclusion, and payment and performance bonds to the City within ten (10) days of the Effective Date. The City will not make any payments under this Agreement until it receives from Contractor the evidence required under this section.
- f. <u>Status Verification Indemnification</u>. Contractor shall indemnify and hold the City and its agents harmless from all claims resulting from any violation of immigration status verification obligations contained in U.C.A. §63G-11-103 et seq.
- g. <u>Post-Retirement Release</u>. Contractor shall release the City from all claims related to any alleged violation of State of Utah post-retirement employment rules, and shall complete and return to the City the attached certification and release.
- h. Governmental Immunity. The City is a governmental entity subject to the Utah Governmental Immunity Act ("Act"; U.C.A. Chapter 63G-7), and does not waive any procedural or substantive defense or benefit provided by the Act or by comparative legislative enactment, including UCA §63G-7-604 regarding limitation of judgments. Any indemnity and insurance obligations incurred by the City under this agreement are expressly limited to the amounts identified in the Act.
- 7. <u>Business License.</u> If required by Tooele City Code §5-1-1 *et seq.*, Contractor shall obtain a Tooele City business license.
- 8. <u>Complete Agreement.</u> This Agreement is the only agreement or understanding between the parties, and may be modified or amended only by a written document signed by both parties.
- 9. <u>Waiver of Jury Trial.</u> The Parties irrevocably waive any and all right to trial by jury in any legal proceeding arising out of or relating to this contract and the transactions contemplated.

### 1. Pledge of Allegiance

Chairman Brady called the meeting to order at 7:00 p.m. and led the Pledge of Allegiance.

### 2. Roll Call

Dave McCall, Present Ed Hansen, Present Melodi Gochis, Present Maresa Manzione, Present Justin Brady, Present



### 3. State of the City Address

Presented by Debbie Winn, Mayor

Mayor Debbie Winn delivered the State of the City address, reflecting on her eight years in office as her second term approached its end. She recalled that Tooele City had once faced serious financial strain, which was corrected through a 2018 property tax increase that restored fiscal responsibility, reduced reliance on reserves, and allowed for long-term investments. She highlighted paying off all Redevelopment Agency debt, ending the city's lobbyist contract, and focusing on accountable economic development.

She emphasized Tooele's resilience through challenges such as fires, an earthquake, vandalism, and the COVID-19 pandemic. She reported progress on the Midvalley Highway, partnerships for youth recreation, beautification efforts downtown, and property purchases for open space and revitalization.

Public safety was a major theme, with Mayor Winn citing the construction of a new public safety building, significant increases in police staffing and pay, and investments in technology such as a 3D scanner and license plate recognition cameras. She noted the growth of the fire department under its first full-time chief, the dedication of a new fire station, and acquisition of new apparatus and equipment.

She also reviewed infrastructure and public works achievements, including new wells, water line replacements, roadway projects, sidewalks, and expanded city equipment. Parks and recreation facilities had been significantly improved, with new playgrounds, courts, trails, and community center upgrades. She highlighted the "Take Pride Tooele" initiative, the addition of more than 500 trees, and ongoing grant-funded projects.

Mayor Winn credited behind-the-scenes work by departments such as Finance, IT, HR, and the Recorder's Office for maintaining compliance, safeguarding resources, and supporting employees. She noted that not a single regular employee was laid off during COVID, and 48 new positions had been added over her tenure.

She emphasized strong partnerships with local organizations, veterans' groups, the Sons of Utah Pioneers, Switchpoint, the Tooele Army Depot, Dugway, and the school district. Economic development had also flourished, with new industrial employers, retail businesses, restaurants, and hotels. She reported that commercial property tax values had doubled in less than five years without offering local tax incentives.

Mayor Winn concluded by acknowledging ongoing challenges with growth, housing, water, and transportation but expressed confidence that Tooele was well prepared with solid plans, funding, and a strong community spirit. She thanked staff, the council, volunteers, and residents, and declared that the state of the city was strong and its future even brighter.

### 4. Public Comment Period

At 7:37 p.m., Chairman Brady opened the floor for public comments.

Mr. Tyler Winn, the mayor's husband, addressed the council. He praised Mayor Winn's dedication and preparation for her State of the City address, noting that she had worked tirelessly to ensure nothing was missed. He shared that over the past eight years they had rarely been out of telephone range because of her commitment to the city, and he expressed appreciation that she would soon be able to retire.

Mr. Winn commended city employees and volunteers, emphasizing the teamwork that supported the mayor and kept the city running effectively. Drawing on his experience as a former member of the fire department, he highlighted the dedication of volunteers who responded at all hours, often at personal expense, and recognized the professionalism of current fire staff. He also shared a story



illustrating the heavy workload of the police department, citing a shift in which officers handled 68 calls. He extended his gratitude to the parks department for their visible improvements throughout the city.

Mr. Winn closed by encouraging residents to be thoughtful and deliberate when voting for future city leaders, urging them to research candidates carefully to ensure continued strong leadership for Tooele City.

Mayor Winn presented an award to Fire Chief Matt McCoy. She noted that he had been hired in June 2022 as Tooele City's first full-time fire chief and had since taken on numerous major projects. She highlighted his pivotal role in the design, coordination, and completion of Fire Station No. 3, which was finished in April 2025 on time and within budget. Mayor Winn stated that the plaque, signed by members of the fire department, was a token of appreciation for his leadership and dedication, and she expressed gratitude for his service and the respect he had earned from his team.

There being no further comments, Chairman Brady closed the floor at 7:44 p.m.

# 5. <u>Public Hearing and Motion on Resolution 2025-79 A Resolution of the Tooele City Council Approving Budget Amendments for Fiscal Year 2025-2026</u>

Presented by Shannon Wimmer, Finance Director

Finance Director Shannon Wimmer presented Resolution 2025-79, the first budget amendment for fiscal year 2026. She explained that several amendments carried over projects budgeted in FY25 but not completed by June 30, including the Cemetery Road project, demolition of the cemetery house, final payments on the headworks building, and projects within the PID. Additional amendments reflected new revenues and grants, such as funds for the drug task force, \$16,500 for a part-time HR employee, \$74,000 donated by Rio Tinto for the museum project, \$1,000 for a buffalo painting sponsorship, and \$1,500 from the State of Utah for the America 250 Utah program.

She also noted smaller adjustments, including \$7,500 to finish new netting at the golf course, funds for the Miss Tooele City scholarships, and restroom projects at Veterans Park and Gleneagles funded by park impact fees. She added that \$4,000 was needed to upgrade the city's time clock system and reported that \$1.7 million would be allocated to begin drilling a new well on Rogers Road following successful testing.

There being no questions from the Council, Chairman Brady opened the public hearing at 7:47 p.m. There were no comments. The floor was closed.

Motion: Councilwoman Manzione moved to approve Resolution 2025-79, a Resolution of the Tooele City Council approving budget amendments for Fiscal Year 2025-2026. Councilman McCall seconded the motion. The vote was as follows: Councilman McCall, "Aye"; Councilman Hansen, "Aye", Councilwoman Gochis, "Aye"; Councilwoman Manzione, "Aye"; Chairman Brady, "Aye". There were none opposed. The motion carried 5-0.

# 6. Resolution 2025-78 A Resolution of the Tooele City Council Approving a Lease Purchase Agreement with Siddons Martin Emergency Group, LLC, for the Lease and Purchase of a Pierce Velocity Aerial Platform Fire Truck

Presented by Matt McCoy, Fire Chief

Fire Chief Matt McCoy presented Resolution 2025-78, seeking approval of a lease-purchase agreement with Siddons Martin Emergency Group, LLC for a Pierce Velocity aerial platform fire truck. He explained that a 2022 fire study identified the urgent need to modernize the department's fleet due to the city's rapid growth and increasing demands from high-density residential and multistory developments. Of the department's two aerial trucks, only one currently meets ISO standards, limiting coverage.



Chief McCoy outlined that the proposal involved a seven-year lease-to-own agreement, beginning with a \$500,000 down payment already budgeted, followed by annual payments of just over \$300,000, for a total cost of \$2,272,293.54. The agreement included prepayment discounts that would save the city more than \$356,000. He described the truck as a mid-mount platform design, making it shorter and able to fit in Station No. 1, while providing a 100-foot aerial ladder with a pump and bucket.

He confirmed that existing trucks would remain in service, with the older ladder truck housed at Station No. 2. Chief McCoy explained that the long-term goal was to create a sustainable replacement rotation, aligning with NFPA guidelines of retiring frontline apparatus after 15 years and reserve trucks after 25 years. Council members expressed support, and Councilman Hansen took the opportunity to publicly thank the fire department, sharing a recent personal experience where firefighters responded immediately to a call at his son's garage. He praised their quick response and professionalism, noting that approximately 50 personnel had arrived on scene almost instantly.

Motion: Councilwoman Gochis moved to approve Resolution 2025-78, a Resolution of the Tooele City Council approving a lease purchase agreement with Siddons Martin Emergency Group, LLC, for the lease and purchase of a pierce velocity aerial platform fire truck. Councilman Hansen seconded the motion. The vote was as follows: Councilman McCall, "Aye"; Councilman Hansen, "Aye", Councilwoman Gochis, "Aye"; Councilwoman Manzione, "Aye"; Chairman Brady, "Aye". There were none opposed. The motion carried 5-0.

### 7. <u>Invoices & Purchase Orders</u>

Presented by Shilo Baker, City Recorder

Ms. Baker presented four invoices for approval. The first was to UDOT in the amount of \$304,296.34 for signal parts for the 2400 North and SR 36 traffic signal, a cost that would later be reimbursed by Smith's. The second invoice was to Russell Welding Corp. for \$34,884.55 for a solar house rail extension at the wastewater treatment plant. The third was to Axon Enterprise for \$124,954.43 for new tasers and related equipment for the Police Department. The final invoice was to Turf Equipment and Irrigation for \$60,305 for a Ventrac mini tractor for the golf course, which could also function as an aerator, seeder, trencher, and stump grinder. No questions or comments were raised by the council.

Motion: Councilman McCall moved to approve the invoices as presented. Councilman Hansen seconded the motion. The vote was as follows: Councilman McCall, "Aye"; Councilman Hansen, "Aye", Councilwoman Gochis, "Aye"; Councilwoman Manzione, "Aye"; Chairman Brady, "Aye". There were none opposed. The motion carried 5-0.

### 8. Minutes
