### RESOLUTION 2026-55

#### **A RESOLUTION OF TOOELE CITY COUNCIL DECLARING A CERTAIN SEIZED AND FORFEITED MOTOR VEHICLE AS SURPLUS PERSONAL PROPERTY AND AUTHORIZING ITS DISPOSAL AND SALE.**

WHEREAS, Tooele City Police Department ("TCPD") previously seized a motor vehicle described as a 2007 Dodge Truck Ram 1500 VIN 1D7HA18K17J504224 ("Vehicle") (photographs attached as Exhibit A) pursuant to a criminal investigation; and,

WHEREAS, the Vehicle was legally forfeited to the City pursuant to civil or criminal forfeiture proceedings under Utah Code Title 77, Chapter 11b (Forfeiture of Seized Property), and the City currently holds clear and valid title to the Vehicle (documentation attached as Exhibit B); and,

WHEREAS, TCPD and City administration have reviewed the municipal fleet requirements and determined that the Vehicle is no longer needed, suitable, or economical for public or law enforcement use; and,

WHEREAS, Utah Code § 10-8-2 authorizes the City Council to sell, convey, or dispose of personal property for the benefit of the municipality when such action is in the public interest; and,

WHEREAS, Section VI of the Tooele City Purchasing Policy, Guidelines, and Procedure ("Policy")<sup>1</sup> provides that "When goods are deemed surplus, outdated, or no longer needed by a department, and are valued at \$100 or more, the Purchasing Agent will recommend the transfer or disposal of the goods. If the Purchasing Agent is recommending disposal, he/she will present a list of all goods valued at \$100 or more to the City Council for approval of disposal"; and,

WHEREAS, the City Council desires to formally declare the Vehicle as surplus personal property and authorize the City Administrator or Police Chief to dispose of it through a public auction, competitive sealed bidding, or another commercially reasonable method to maximize recovery for the municipal general fund or law enforcement account:

NOW, THEREFORE, BE IT RESOLVED BY THE TOOELE CITY COUNCIL:

1. Declaration of Surplus Property: The motor vehicle described below is hereby declared to be surplus personal property of Tooele City:
  - o Year: 2007
  - o Make / Model: Dodge / Ram 1500
  - o Vehicle Identification Number (VIN): 1D7HA18K17J504224

- Title Status: Clear Title Held by City
- 2. Authorization of Disposal and Sale: The City Council authorizes the disposal of the Vehicle "as is" with no express or implied warranties, utilizing a commercially reasonable public sale method. The Mayor is authorized to execute any title transfers, bills of sale, or associated documentation required to complete the transfer of ownership to the purchaser. Net proceeds shall be allocated and deposited as ordered by the court in accordance with Utah Code § 77-11b-401(3).

This Resolution is in the best interest of the general welfare of Tooele City and shall become effective upon passage, without further publication, by authority of the Tooele City Charter.

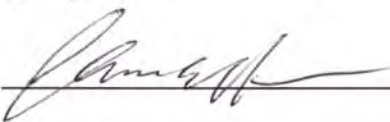

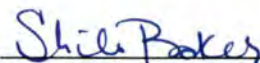
